## EDGEFIELD COUNTY WATER & SEWER AUTHORITY BOARD MEETING MINUTES

The February Regular Board of Directors Meeting of Edgefield County Water and Sewer Authority was held on February 27, 2023, starting at 5:30 p.m. at 100 Waterworks Rd., Edgefield, SC (ECWSA Administrative Building). No individual or organization requested a copy of the Agenda. Notice of this Board of Directors Meeting was posted in the Administration Office 4 weeks prior to meeting and the Agenda was posted February 24, 2023.

**AGENDA:** A motion was made by Johnson to approve the February 27, 2023 Agenda. Second by Washington. Vote unanimous to approve the agenda.

MINUTES: A motion was made by Johnson to approve the January 23, 2023 Minutes. Second by Creswell. Vote unanimous.

PUBLIC COMMENT: Annette Holloway was originally scheduled to attend the Board meeting, but elected to meet with Chairman Kennamer and Administrator Hare on Friday to share concerns about water in the Northside of the county. As Hare was recapping the meeting, Mr. Dennis Wall asked to speak. He shared his concerns over well damage related to the explosives testing facility in the Northside. Hare and Kennamer shared the overall cost of over \$24 million to extend water to the Northside. Mr. Wall asked to look into the possibility of connecting to McCormick County's water system. Hare told Wall that the Authority would continue to look for alternatives that would be fiscally feasible to extend water. Kennamer also said that if water were to be extended, it would have to be extended to the Westside as well, effectively doubling the cost of the project.

FINANCIAL STATEMENT: After the reading of the bank balances, Administrator Hare discussed the Financial Statement ending January 31, 2023. Budget should be at 58.33%, Revenues are 65.22%, and Expenses are at 55.47%. Water & Sewer sales are still ahead of last year.
