EDGEFIELD COUNTY WATER & SEWER AUTHORITY BOARD MEETING MINUTES

The March Regular Board of Directors Meeting of Edgefield County Water and Sewer Authority was held on March 28, 2022, starting at 5:30 p.m. at 100 Waterworks Rd., Edgefield, SC (ECWSA Administrative Building). AGENDA: A motion was made by Johnson to approve the March 28, 2022 Agenda. Second by Smith. Vote unanimous to approve the agenda.

PUBLIC COMMENT: No comments from the public and no one present from the public.

FINANCIAL STATEMENT: After the reading of the bank balances, Administrator Hare discussed the Financial Statement ending February 28, 2022. Budget should be at 66.67%, Revenues are 68.54%, and Expenses are at 64.6%. Water & Sewer sales are in line with last year. Administrator Hare also discussed the Authority would be looking at other potential options on property insurance as potential money savings in the next budget cycle.

BUSINESS

A. Administrative Building Upgrades

Administrator Hare presented a bid from McWaters for paint, flooring, and construction on the Administrative Building. The paint and floor covering in the old section of the office dates back to the early 1990's .The bathrooms will be upgraded to ADA Standards with the lobby being slightly reduced in size. McWaters is a S.C. State Contract vendor. Hare recommended proceeding with the combined bid of \$130,618. A motion by Kitchens was made to accept the bid. Second by Clark. No discussion. Vote unanimous.

B. FY2023 Budget Work Session (Non-Voting Business)

Chairman Kennamer and Administrator Hare led the Board on a wide ranging work session concerning the upcoming budget. Items of concern were the inflation rate (8.4%) driving up Authority costs, and how that would apply to potential rate adjustments and employee salaries. Thoughts and opinions were shared on these items to give Administrator Hare guidance in preparation for the 1st Draft of the FY 2023 Budget.
