The October Regular Board of Directors Meeting of Edgefield County Water and Sewer Authority was held on October 28, 2024, starting at 5:30 p.m. at 100 Waterworks Rd., Edgefield, SC (ECWSA Administrative Building). AGENDA: A motion was made by Johnson to approve the October 28, 2024 Agenda. Second by Smith. Vote unanimous to approve the agenda.

MINUTES: A motion was made by Johnson to approve the September 23, 2024 Minutes. Second by Smith. Vote unanimous.

PUBLIC COMMENT: None

PRESENTATION OF THE FY 2024 AUDIT: Grant Davis presented the ECWSA FY 2024 Financial Audit. Overall, the Authority's finances are in excellent shape, as pointed out by several financial metrics. No deficiencies were noted in the audit, and Davis expressed to the Board M&J's continued appreciation for the cooperation of staff during the audit. A motion was made by Kitchens to accept the FY 2024 Audit. Second by Smith. No discussion. Vote unanimous.

FINANCIAL STATEMENT: After the reading of the bank balances, Administrator Hare discussed the Financial Statement ending September 20, 2024. Budget should be at 25%, Revenues were at 22.27% and Expenses were at 24.87%. Hare pointed out to the Board that these numbers were skewed since the Authority did not bill during the month of September due to Hurricane Helene, resulting in little to no revenue for water and sewer usage. This should be rectified during October.

REPORTS:

John Hare, Administrator covered the following items during the report section:

• Administrator Hare gave an in-depth review of Hurricane Helene's damage and aftermath to Authority facilities. He specifically pointed out that the Authority would

A. PURCHASE OF A ROTATING ASSEMBLY FOR PINEHOUSE L/S

Administrator Hare presented to the Board, the need to purchase a new rotating assembly for the Pinehouse pump station from Tencarva for \$30,990.65. A motion was made by Creswell to purchase the rotating assembly. Second by Kitchens. No discussion. Vote unanimous.

B. HURRICANE HELENE WORK BONUSES

Chairman Kennamer recommended the Board consider a bonus for employee's due to the "above and beyond" service given by staff during the Hurricane. Johnson made a motion to enter Executive session to discuss since it was a personnel matter. Second by Kitchens. Exited Executive Session with no action taken.
